#### Structure, governance and management

The charity is a company limited by guarantee and was formed on 30 December 2010. It is governed by articles of association as amended 20 July 2011 and 15 May 2015. The liability of the members in the event of the company being wound up is limited to a sum not exceeding £1.

#### Method of recruitment and appointment of trustees

The trustees of the charity are also the directors for the purposes of company law and are appointed by the members at the AGM.

#### Objectives and activities

### The charity's objects

To preserve and protect the health and to advance the education and development of children and adults who have communication difficulties and people important to them (family / carers / supporters), particularly by assisting or encouraging people using alternative and augmentative communication (AAC) within the United Kingdom to achieve their communication potential, and to make provisions or promote any scheme thought necessary to meet this aim.

To advance the education of the public, to increase their awareness and understanding of AAC.

#### Objectives and activities (continued)

#### The charity's main activities

1 Voice creates opportunities to bring together children and adults who use augmentative and alternative communication (AAC) and people important to them (family / carers / supporters) to share ideas, information, skills and personal experiences.

1 Voice holds residential event(s) each year and local activities throughout the year supported by regional committees.

1 Voice further aims to reach out to the wider public to increase awareness through published newsletters and internet based presence such as website and social media platforms.

#### Public benefit statement

In setting our objectives and planning our activities our trustees have given serious consideration to the Charity Commission's general guidance on public benefit and in particular the relief of disability such as working with families and children with complex needs and speech impairments.

#### Achievements and performance

#### National Residential Weekend – Derbyshire – 1 Voice 1 Vote

This took place the weekend after the General Election, so we took the opportunity to encourage participants to think about voting, through a range of age-appropriate communication activities. This culminated in an election where each group presented their policies to everyone attending, using their AAC devices, and a vote chose the winning group. They impressed us with a wide range of both serious and entertaining ideas, some of which were focused on the needs of disabled people. Meanwhile, parents worked on their AAC manifesto, considering what young AAC users and their families need from the NHS, schools and other organisations supporting them, and putting together their recommendations for best practice. Everyone enjoyed activities to get to know people, presentations from some of our participants and a lively disco. Feedback showed that both AAC users and family members found the event useful, supportive and inspirational. 97 people attended the event, of whom 24 were AAC users, 52 family members and personal assistants, and 21 volunteers and trustees. In keeping with our aim for including new families. we had 5 new families this time.

#### 1Voice-1Day 2015 - Leeds

For the second year, we organised a day for AAC users within reach of Leeds to take place at the University immediately prior to the start of the national Communication Matters conference, which brings together adult AAC users and professionals working in the field of AAC. This meant that families and younger AAC users attending the 1Voice day could also visit the CM exhibition and talk to suppliers of equipment, and some adult AAC users and parents could easily attend both events. The day's activities focused on holidays, with young AAC users talking about the kinds of holiday they would like and what they would like to do, while adults, including parents, shared ideas and experiences about travel with disabled family members and independent travel for adult AAC and wheelchair users, and identified useful sources of information to disseminate. As always, everyone enjoyed a chance to chat with other AAC users and families.

<u>Future locations for National events:</u> Toward the end of this fiscal year, we identified two other locations that could be very good for our future national events. Due to the expanding membership and those wishing to attend the national event, we really needed to find locations with fully accessible facilities. This was achieved and two special needs colleges – Derwen in Shropshire and Treloar in Hampshire are pre-booked for our 2017 and 2018 events. This will also be an opportunity to encourage more attendees from the west, Wales and the south of the UK.

#### Achievements and performance (continued)

#### Branch events

During the fiscal year 6 active branches held 18 events, attended by 321+ participants.

Branch level events included social gatherings at restaurants, bowling alleys, visits to places such as children's farms, wetlands centres, boat trips and adventure centres; whilst some branches had themed activity days such as an immersive theatre experience, a safari park visit and use of sensory centres around the country. All of these places and activities included expanding communication skills of those attending. The themes and locations were used to expand vocabulary skills.

Pop Ups: Where we do not have an organised branch, we tried to engage the public in Pop-Ups. During this fiscal year we met in three places: Essex, Ruislip, and Warrington. Families came to find out what 1Voice is about and through discussion, explore the possibility of forming a branch committee. Mixed success. As always it really relies on professionals eager to do some volunteering. Families with AAC user are generally overwhelmed with medical and educational issues, that volunteering is the last thing on their list.

However, these local/branch level events also contribute to our efforts to reach out to the general public and to educate them on Augmentative and Alternative Communication. Whenever we are out in public places, we meet someone that has never seen an AAC user before.

#### Newsletters

Two newsletters have been distributed this year. They include articles about events and members' activities, news of interest to AAC users, fundraising information, and we have introduced an element of symbol communication to encourage members who "read" through symbols.

#### Representation at events

1 Voice attended several functions, again to meet our objective of promoting wider public awareness of AAC. We had a table and representation at the Lonsdale School Communication Showcase event. Nadia C, one of our Role Models, attended a Parent Day in a Rotherham school. Natasha B and her mother attended a group AAC evaluations committee in Derbyshire, as well as events at a school where a group of young swimmers were preparing a Channel swim to raise funds for 1 Voice. Our Trustee and AAC Role Model Helen Quiller attended an NHS forum meeting on AAC delivery.

1 Voice is a member of the Communication Trust, a coalition of over 50 non-profit entities that support the Speech, Language and Communication Needs (SLCN) of the general population. We have a member who represents us at the regular meetings held in London. We are contributing to and trying to influence the national agenda around this support.

Membership: our membership is now at 505, a 20% increase over the last fiscal period. There is a good mix of AAC users, families and professionals interested in our support services.

#### **Financial review**

The net expenditure for the year was £10,739, including net expenditure of £9,438 on unrestricted funds and net expenditure of £1,301 on restricted funds.

#### Reserves policy

The charity's free reserves at the year end were £22,620.

The charity's free reserves, excluding designated reserves at the year end were £9,656.

The Trustees formulated a plan to maintain a reserve balance of £2,000. This will cover commitments over 1 year, should the charity cease to secure funding and operate.

Whenever feasible, the trustees like to keep enough funds in the accounts to cover the cost of the next National Event. Based on historical data, that would mean an additional reserve of £15,000.

We are below our desired level of unrestricted, designated reserve for the next National Residential Weekend. We are looking at ways to fund a fundraiser to help us win grants and funding.

#### Statement of trustees' responsibilities

The trustees (who are also the directors for the purposes of company law) are responsible for preparing the Trustees report and the financial statements in accordance with the applicable law and UK Accounting Standards.

The trustees are responsible for keeping proper accounting records which disclose with reasonable accuracy at any time the financial position of the charitable company and to enable them to ensure that the financial accounts comply with the Companies Act 2006. They are also responsible for safeguarding the assets of the charity and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

#### 1 Accounting policies

#### Basis of accounting

The financial statements have been prepared under the historical cost conventio. The financial statements have been prepared in accordance with the Statement of Recommended Practice: Accounting and Reporting by Charities (Charities SORP (FRSSE)) the Companies Act 2006 and Financial Reporting Standard for Smaller Entities (effective January 2015).

There has been no change to the accounting policies since last year.

No changes have been made to the accounts for previous years.

#### Incoming resources

All incoming resources are included in the Statement of Financial Activities (SOFA) when the charity becomes entitled to the resources, the trustees are virtually certain they will receive the resources and the monetary value can be measured with sufficient reliability.

#### **Grants and donations**

Grants and donations are only included in the SOFA when the charity has unconditional entitlement to the resources.

Where grants are related to performance and specific deliverables, they are accounted for as the charity earns the right to consideration by its performance.

#### **Expenditure and liabilities**

Expenditure is recognised on an accrual basis as a liability is incurred. Liabilities are recognised as soon as there is a legal or constructive obligation committing the charity to pay out the resources.

#### **Taxation**

As a charity the organisation benefits from rates relief and is generally exempt from income tax and capital gains tax but not from VAT. Irrecoverable VAT is included in the cost of those items to which it relates.

#### Tangible fixed assets

Tangible fixed assets costing more than £500 are capitalised and included at cost including any incidental expenses of acquisition. Gifted assets are shown at the value to the charity on receipt.

Depreciation is provided on all tangible fixed assets at rates calculated to write off the cost on a straight line basis over their expected useful economic lives.

#### Stock

Stock is included at the lower of cost or net realisable value.

#### **Fund accounting**

Unrestricted funds are available for use at the discretion of the trustees in furtherance of the general objectives of the charity.

Designated funds are unrestricted funds earmarked by the trustees for particular purposes.

Restricted funds are subjected to restrictions on their expenditure imposed by the donor or through the terms of an appeal.

Further explanation of the nature and purpose of each fund is included in the notes to the accounts.
